Although we take great care to oversee the safe movement of your cargo, there is potential for loss or damage due to the perils of extreme weather, rough handling, and theft as well as many other unforeseen occurrences. We strongly recommend protecting your cargo by accepting our offer of cargo insurance. Please review the following information prior to making your decision.

Compare the value of your cargo against the monetary liability of Carriers.

Mode of Transit	Limit of Liability
<b>Ocean Carriers</b>	\$500/package or Customary Shipping Unit (CSU) based on the Carriage of Goods by Sea Act (COGSA).
<b>International Air Carriers</b>	\$9.07/lb. or approx. \$20/kg. under Warsaw Convention 19 SDRs* (Approx. \$29/kg.) under Montreal Convention or Warsaw Convention as amended by Montreal Protocol 4.
<b>Domestic Airlines, Trucks &amp; Railroads</b>	\$.50/lb. customary \$.50/lb. customary, limited by tariff Limited
<b>Couriers &amp; Warehousemen</b>	\$100 or less any one shipment Limited, no statutory federal protection

Carrier's statutory liability does not provide the same protection as cargo insurance. Consider the comparisons below:

If TWI has not received request to insure your cargo at least 2 days prior to consolidation point deadline, specified in the shipping instructions, coverage will auto-decline. In the event of loss or damage, the maximum liability of TWI is \$50.00

## TERMS & CONDITIONS:

I understand that all claims are subject to a deductible of two percent (2%) per incident with a minimum deductible of USD \$250 and no maximum. If the insured value is less than \$2,500, please note that your deductible will be \$100. This deductible is based on the full value of the policy, not the value of the claim.

I also understand that the insurance policy will be written for 110% of the CIF value (Commercial value listed on your invoice + Insurance Premium + Freight cost for shipping goods + 10%).

The rate for insurance coverage is based on 110% of the CIF value and currently charged at US .9225¢ per \$100.00 of CIF value for worldwide transits, and US .60¢ per \$100.00 of CIF value for transits from origins in the U.S.A. and/or Canada to exhibition sites within the U.S.A. and/or Canada.

The minimum premium charge is USD \$60.00 | \*Please contact your representative at TWI for more information.

TWI reserves the right to change the rates mentioned above without notice. Rate may change if goods do not travel as indicated below. Shipments to certain countries may be subject to war/SRCC surcharges.

Red Stripe and A.P.L.C. shipments will be insured on a one-way basis only. Please note shipping containers are not covered under this policy unless the containers are listed on the commercial invoice you submit with this application. Special rates may be used for goods that vary from the transit mentioned above. Cargo insurance for transit to exhibition, whilst there for a period not exceeding 30 days, and return transit to origin.
